Judge Henderson reported that due to prevailing drought conditions, he, by executive order, had issued a county-wide burn ban on Tuesday, ~~June 26th~~ ^{June 26th}, and that city officials were considering a fireworks ban for the city during the 4th of July holiday observance. After discussion among court members regarding this matter, it was the consensus of the court to add the fireworks ban to the executive-ordered county burn ban as well. There was an acknowledgment of the plight of those who had paid permit and license fees to set up temporary fireworks stands. The court felt they should be given the opportunity to request refunds if they chose not to continue with their fireworks sales.
