Judge Henderson announced that Fiscal Court will meet in special-called joint session with the Franklin City Commission, Tuesday, October 15th at noon in the Historic Courthouse County Court Room. Fiscal Court will meet in regular session at 8:30 A.M. that same date.

Greg Grauer, a resident of Boat Ramp Road, spoke to Fiscal Court about the dangerous conditions including a blind curve due to over growth of vegetation, a steep bank and obstructions due to fishermen parking vehicles and trailers along the road. A school bus regularly travels this road increasing the need for correction of these issues. The judge and Magistrate Chandler will ask Public Works Director Bobby Groves to assess the conditions of the road and make recommendations to address these safety concerns.

Magistrate Randolph reported that Simpson County Public Works did a good job of ditching on Perdue Road preparing for paving set to begin today.

Magistrate Tarpley announced that a benefit dinner at the Brickyard for the Farmers' Market pavilion is scheduled for tonight.
