At a regular meeting of the Simpson County Fiscal Court held in the Fiscal Court Meeting Room in the Simpson County Historic Courthouse, July 21, 2015, at 9:05 AM

Judge Henderson called the meeting to order and led in prayer followed by the pledge of allegiance to the American flag.

Pete Reckard, District Manager for Scott Waste Services, spoke to Fiscal Court regarding the transition from Waste Management to Scott Waste on July 1st. Both he and Judge Executive Jim Henderson assessed the process overall as relatively smooth considering the magnitude of the project. He assured the court and customers that their carts are actually one gallon larger despite the perception of them being smaller because they are shorter than those of previous hauler Waste Management. He explained that some re-routing for efficiency purposes is likely to occur in the future but customers will be notified. On another subject, Mr. Reckard commended Simpson County Sheriff's Chief Deputy Steve Chappell who had recently volunteered his services as a judge for a garbage truck rodeo held by Scott Waste.
