Magistrate Bobby Bush reported from the Library Board that demoition of the small house located behind the library and owned by the library has been completed. The demo was necessary due to mold throughout the structure.

Magistrate Marty Chandler acknowledged graveling of the shoulders of several roads done by Public Works.

Motion by Tarpley Second by Chandler Yes-Bush, Chandler, Randolph, Tarpley & Henderson With \$85,000 left in the current road budget, authorize resurfacing of Mallory Road, J.L. Farmer Road and associated work and streets of County Club Estates at an estimated cost of \$90,000.

Sheriff Hopson reported that property tax collections are now the responsibility of the County Clerk and while penalties will now apply, paying those taxes plus penalties will be better than properties being sold to third parties, which is what happens if not paid.

Judge Henderson offered a clarification regarding allowable meal and travel reimbursement. When clarity is in question, default to current state policy will be followed. The current administrative code may need to be amended if issues persist with regard to this problem.

Judge Henderson reported that inquiries regarding a consolidation of city and county governments have begun to resurface in recent weeks. In response to these inquiries, he provided a copy of KRS 67.830 regarding procedure for adoption of charter county form of government or for consolidation of services or functions and explained that this needs to be a grass roots initiative. Both he and some magistrates have been contacted regarding this subject.
