Jailer Eric Vaughn and Judge Henderson will continue to explore financing options for the proposed purchase of the \$189,000 body scanner for the jall.

Judge Henderson reported figures from calculations reflecting possible retirement rate increases based on payroll figures from FY16-17. With the projected increased rates for non-hazardous duty and hazardous duty employer matches, the county should be prepared for an estimated total increase, including all departments, of \$371,277.80. (See calculations in Attachment File.) He encouraged department heads to be mindful of this Information as budget preparations begin for the 2018-19 fiscal year. After meeting with a small work group of county officials from around the state and Governor Bevin, the judge's most recent information regarding the CERS and state pension plans included the following four points. There will be no advantage to retiring now, no benefits that have been accrued will be taken away, a commitment to the pension promise that has been made will continue to exist and there will be zero changes for current retiress.
