County Judge Executive Mason Barnes called the fiscal court meeting to order with Magistrate Scott Poston opening the meeting with prayer followed by the pledge of allegiance to the American flag.

There was no public comment.

LuAnn Ferguson addressed court requesting the establishment of a county cemetery preservation board. She explained that grants are available from various sources for cemetery preservation and if a cemetery preservation board is in place, grants are more likely to be awarded and there can be more oversight in taking care of cemeteries. The establishment of such a board in no way obligates any fiscal responsibility of the county. Magistrate Marty Chandler expressed interest in serving on this board as did Ms. Ferguson with other appointments to be made according to Kentucky statute.

Facilities Maintenance Supervisor Bill Rohrs presented a detailed report and photographs of the jail roof in response to Jailer Vaughn's request at the January 7<sup>th</sup> meeting for the jail leaks to be addressed. Mr. Rohrs' report and photographs are included in the January 21, 2020 Attachment File. He reported that KACO insurance will cover the \$8,300 less the \$500 deductible due to hail damage being discovered on the roof.
