Fiscal Court acknowledged Judge Barnes Executive Order #2020-10-20 which pursuant to KRS 67.711 appointed Pam Rohrs as Deputy Judge Executive through December 31, 2022.

During Judge Barnes' report he expressed his appreciation to Public Works for all that has been done to make the intersection of Schweizer and Kummer roads safer and for the days that the crew has spent on the courtyard removing overgrown shrubbery, resodding, repairing sidewalks and improving drainage issues. He also announced that the Barren River District Health Department will have a drive-thru flu vaccination clinic set up at the community park on this date from 9:00 AM 'til noon.

Magistrate Chandler reported that the county surplus equipment auction is scheduled for Saturday, October 24th at the county barn on Kenneth Utley Drive. He also reminded folks that early voting for the 2020 General Election is in progress here at the Historic Courthouse weekdays 8:00 AM 'til 4:00 PM, Saturdays 8:00 AM 'til noon prior to election day and polls will be open on election day from 6 AM 'til 6 PM at the Historic Courthouse, Simpson Elementary on Witt Road and the Ag Building at the community park.

Magistrate Downey reported that kids at the Boys and Girls Club are coming back to the club in a staggered schedule similar to the school schedule and that the board is seeking new members as some board terms will expire soon.

Magistrate Poston reported that the bridge replacement over Sinking Creek on HWY 621 is still in progress and that he will pass along a report of a large hole on Salmons Blackjack Road to State Highway Department.

Magistrate Thurman commended Public Works implementing additional safety measures at the Schweizer/Kummer roads intersection and also the efforts of the jail to take steps to achieve efficiency in utility management at the facility.

Attorney Sam Phillips commended PVA and the Sheriff's Office in getting tax bills out in a timely fashion this year. He also expressed appreciation for the community's participation in the annual Rotary Club Reverse Raffle held virtually this year due to COVID-19.

Jailer Eric Vaughn said that he was working with DOC to try to get state inmate numbers increased which have been at a lower population during the COVID pandemic.
