Judge Barnes shared a letter from the F-S Industrial Authority Executive Director Dennis Griffin commending Simpson County Public Works Director Bobby Groves and his execution of a solution addressing an unauthorized access issue into the Henderson Industrial Park. The judge also announced that the Martin Luther King Day Breakfast would be conducted virtually this year on January 18th. Judge Barnes asked Magistrate Downey if the Parks Board had met recently and since they had not, Mr. Downey could not answer whether or not spring sports would be available through the park system this year. Judge Barnes expressed his opinion that since football and basketball have been allowed, it should be possible for activities such as baseball and softball be allowed this spring. Magistrate Downey explained that closures of activities last year through the park system were at the direction of state mandates.

Magistrate Chandler presented a petition of twelve residents on Loving Chapel Road requesting a guardrail be installed at the intersection of KY HWY 100 and Loving Chapel Road. Public Works Director Bobby Groves and Magistrate Chandler explained that they have talked with the state highway department since the requested guardrail would be in the right-of-way of the state highway. The state highway's standard for a guardrail is at least a 2-to-1 slope and this slope is about 4-to-1. The state's philosophy is that a guardrail at this location could create a greater risk of injury. Simpson County Public Works has installed reflectors at this site in the county right-of-way.

Magistrate Poston reported that the bridge replacement on HWY 621 (Stevenson RD) has been completed and the road is now open for thru traffic.

Emergency Management Director Robert Palmer reported that this week should bring a second opportunity for area first responders to receive their first COVID vaccinations with vaccinations available to folks seventy and older soon according to information he had at the time of this meeting. Details of when and where is yet to be announced and information is constantly changing. Mr. Palmer commended Post 3, KSP Dispatch's professionalism in handling emergencies on Christmas Day when the bombing in Nashville interrupted AT&T services impacting emergency communication systems in Kentucky and surrounding states.
