At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, February 2, 2021, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order and Magistrate Poston opened with prayer followed by the pledge to the American flag. This meeting was streamed live on Facebook to maintain compliance with the measures associated with the COVID-19 pandemic.

Approve January 19th regular fiscal court meeting minutes.

Motion by Poston Second by Thurman Ayes-Chandler, Downey, Poston, Thurman & Barnes
Approve second reading and final passage of FY20/21 Budget Amendment No. 7 Ordinance No. 220.223 in the amount of \$95,562.00.

Motion by Chandler Second by Poston Ayes-Chandler, Downey, Poston, Thurman & Barnes
Approve first reading of Ordinance No. 310.25 repealing Ordinance No. 310.21 and regulating the collection of subscriber fees-membership dues for residents within the five-mile radius of the Woodburn Volunteer Fire Department Station and providing for the sheriff to charge a 4.25% commission for collection of these dues and fees.

Motion by Downey Second by Poston Ayes-Chandler, Downey, Poston, Thurman & Barnes
Approve first reading of Ordinance No. 310.26 repealing Ordinance No. 310.24 and regulating the collection of subscriber fees-membership dues for residents within the five-mile radius of the Plano Fire Department and providing for the sheriff to charge a 4.25% commission for collection of these dues and fees.

Authorize renewal of the lease agreement with the Administrative Office of the Courts for the Drug Court building located at 209 East Cedar with the same terms and conditions which include an effective date of July 1, 2021 and ending June 30, 2022 with automatic renewal for an additional period of 24 months unless amended in writing or until the AOC ceases to occupy the leased premises and authorize Judge Executive Mason Barnes to sign the agreement.

Authorize renewal of the Interlocal Cooperation Agreement through June 30, 2022, between the Department of Kentucky State Police and Simpson County "to promote public safety by the continued maintenance and operation of a Public Safety Answering Point to answer all enhanced 911 calls originating from the County in order to dispatch public safety services or to extend, transfer or relay 911 calls to appropriate public safety agencies" and authorize Judge Executive Mason Barnes to sign this agreement with the stipulation that before the next year's renewal is approved, Fiscal Court must be provided information of the amount of revenue generated by Simpson County cell phones.

*It was noted that even though requested on numerous occasions, this information has never been provided to Fiscal Court by any entity.

Authorize advertising for mowing of county properties as requested by Public Works Director Bobby Groves.

Authorize Planning & Zoning Administrator Carter Munday, by and through County Attorney Sam Phillips, to pursue measures to determine ownership of a vacant and dilapidated house located at 548 Vances Mill Road so that steps can be taken to levy fines and eventually have the structure demolished.
