At a regular meeting of the Simpson County Fiscal Court held in the Courtroom of the Simpson County Historic Courthouse, Tuesday, May 18, 2021, at 8:30 AM

County Judge Executive Mason Barnes called the fiscal court meeting to order and County Attorney Sam Phillips opened with prayer followed by the pledge to the American flag.

Pursuant to KRS 42.455 and KRS 174.100, Judge Barnes opened the public hearing, as advertised, for the County Road Aid (CRA) and Local Government Economic Assistance (LGEA) for public comment regarding use of the restricted funds from motor fuels taxes with FY21-22 projected revenue of \$808,484 and \$181,400 from LGEA funds from taxes on minerals, mostly crushed stone, mined in Simpson County. There was no public comment at this hearing and it was noted that there had been none from phone calls or written comment to the County Judge's office prior to the hearing. The hearing was closed.

Jon Sowards, President/CEO of SouthCentral Workforce Development Board, was seeking the court's review and approval of an updated Interlocal Agreement for the ten-county Barren River Area Development District which includes the counties of Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, Simpson and Warren. The update to this agreement, which was initially approved in 2015 and amended in 2016, establishes that the locally elected officials (LEOs) within this board will enter into the agreement, they will be responsible for selecting and appointing fiscal agent services and each local jurisdiction is liable for misuse of funds and recoupment of any disallowed costs could come back to the locally elected official's jurisdiction. An audit by the state and another by an external agency are conducted each year. The CDL program at the local SKYCTC is one of the main programs of the Workforce Development Board. A resolution authorizing entering into this Interlocal Agreement will be prepared for the June 1<sup>st</sup> regular fiscal court meeting.

 Approve April 30<sup>th</sup> Financial Statement as submitted subject to audit and authorize signatures of County Treasurer Nicole Law and County Judge Mason Barnes.

Judge Barnes reminded folks of the Job Fair to be held Wednesday, May 19<sup>th</sup> from 9:00 AM - 2:00 PM at SKYCTC. According to the Scott Waste's District Manager Pete Reckard's report there was a total of approximately 97 residents that came to Scott Waste's Amnesty Day on Friday, April 23<sup>rd</sup> and 65 on Saturday April 24<sup>th</sup> at the convenience center at 2416 Kenneth Utley Drive. A total of eight 40-yard containers collected 17.8 tons. Judge Barnes had received a letter from Scott Waste Services advising him that due to the consumer price index their annual rate increase will be 2.53% effective July 1, 2021, raising the residential quarterly rate to \$40.86 and the new commercial rate to \$4.56 per yard. There was discussion about complaints that the convenience center was not always open as posted. The current contract states that hours are Tuesday and Friday from 8:00 until 4:30. It was suggested that Judge Barnes write a letter to Mr. Reckard regarding those complaints and County Attorney Sam Phillips will review the contract, particularly, looking at what recourse the county might have if Scott Waste was not in compliance with the terms of the contract. Judge Barnes also announced that Julie Freeman, administrative assistant in Planning & Zoning, tendered her retirement notice effective June 30, 2021.

Magistrate Chandler announced that much needed repairs to HWY 585 (Gold City Road) have begun. He stated that there are currently thirteen homes on this road.

County Attorney Sam Phillips encouraged folks to pay their 2020 property taxes which are now at the county clerk's office and noted that they may contact his office to make payment arrangements if need be.
