County Judge Executive Mason Barnes called the fiscal court meeting to order and Magistrate Poston opened with prayer followed by the pledge to the American flag.

Magistrate Chandler reported that EMS Director Dale McCreary will be retiring July 3rd. He also reported that the mowing of state roads has begun and said that he would like to see county roads cleared of mown grass as it can be dangerous to cyclist especially if wet. He continued by cautioning motorists to be aware of farm equipment on the move during this season.

Sheriff Hopson reported approximately \$63,000 from the surplus sale held the day before at the Sheriff's impound lot. Items from his department, the drug fund, the jail, fiscal court and circuit and district courts had items in the sale. A detailed report will be available at a later date.

Judge Barnes continued his report that the South Central Kentucky Drug Task Force will officially be relocating to Simpson County July 1st. According to Simpson County Public Works Director Bobby Groves an estimated 15,000 tires were collected in the tire collection event held last week at the county barn. This opportunity is made possible every three years in cooperation with the Kentucky Division of Waste Management.
