Specifications may be picked up at the County Judge Executive's Office during normal business hours of 8:00 AM – 4:00 PM Monday thru Friday. Materials shall meet 2018 Kentucky Department of Transportation specifications. Award will be made on the basis of the lowest and best bid with the right to accept or reject any or all bids being expressly reserved. 1. Bituminous Concrete Surface for resurfacing roads in place anywhere in Simpson County. The bid will include tack oil, .05/gallon per square yard, and heeling back shoulders, including any necessary grade work to prepare for asphalt surface.

3. Trenching per Linear Foot: The bidder will excavate a trench approximately 3" in depth and a width of approximately 18" each side of roadway. Placing bituminous concrete base in trench and compacting shall be paid for as per ton bid price for bituminous concrete base. The cost of removing excess material from excavated areas will be incidental to bid item of trenching per linear foot.

4. DGA for shoulders in place, on a "per ton basis". Simpson County will have the option in which roads are to receive a DGA shoulder.

5. Ditching & Shouldering: The bidder will ditch and shoulder various roads in Simpson County as directed by the County. Fill material, removing and replacing mailboxes, and installing driveway intersection pipe shall be incidental to the bid. The cost of new pipe shall be quoted at a unit price per job.

6. Seeding & Protection: The bidder will seed and straw ditches & shoulders along various roads in Simpson County as directed by the County.

NOTICE TO BIDDERS:

Simpson County is seeking bids for provision and delivery of hot mix asphalt (HMA) paving material and/or application of paving material on County roads, along with other incidental and ancillary road restoration items, at the direction of Simpson County. The term of this contract will be for the period ending June 30, 2019. The most responsive bid shall include the following specifications and requirements:

- All items in this bid shall be constructed based on the Kentucky Transportation Cabinet's most recent standard specifications for road and bridge construction.
- All contractors and/or subcontractors shall be pre-qualified with the Kentucky Transportation Cabinet under work items C, C-1 & C-2 in order to bid bituminous paving projects with the Simpson County Fiscal Court.
- All materials required for this bid, including, but not limited to, Liquid Asphalt, Aggregates, and Asphalt material for tack coat, must be from an approved Kentucky Transportation Cabinet source.
- Asphalt plant and site testing as required by the Kentucky Transportation Cabinet shall be provided at the contractor's expense, if requested by the Simpson County Fiscal Court. Testing shall be performed by a state qualified superpave technologist.
- Bidders shall provide at least five (5) references for relatively local municipalities and/or counties for which you have provided hot mix asphalt application similar in scope to that requested by Simpson County. Include a description of work performed, as well as a contact name and corresponding phone number or email address.
- The attached Statement of Bidders Qualifications must be included with the bid.

Bids will be received at the office of the Simpson County Judge/Executive until 10:00 AM, Friday, April 27, 2018. Award will be made on the basis of the lowest and best bid with the right to accept or reject any or all bids being expressly reserved.
